#### We are a 'School-wide' Title 1 School

 Our school is supported by Title 1 funds to help supplement the needs of our students and programs.

- As a school community we qualify for Title 1 funding due to our economic status which helps level our funding with those districts with a higher tax base.

#### What is Title 1?

• Title 1-A is the largest Federally funded K-12 program that provides additional academic support and learning opportunities for students at schools with high percentages of socioeconomically disadvantaged children.


 The program is intended to help ensure that all students meet state academic standards in reading and math.




#### **Title 1 Funds**

[Federal Funds]

 Allocated on basis of number of students eligible for free/reduced lunch.
 Schools receive Title I funds if 40% or more of students are eligible for free/reduced lunch.





#### Title 1 Funds (cont.)

- 1% of a school's total Title 1 budget is for parent involvement activities.
- Schools in Program Improvement must set aside a minimum of 10% for professional development.
- Funds must supplement, not supplant, district


#### **Goals of Title 1**

- Increase academic achievement.
- Provide direct instructional support to students.
- Provide professional development for teachers.
- Promote parent education and involvement.



# The Title 1 Parent Involvement Policy

Every Title I school, in collaboration with parents, must prepare a site level parent involvement policy. The Parent Involvement Policy describes how the school will involve the parents in an organized, ongoing, and timely way in the planning, review, and improvement of the Title I program at the school.





#### **School-wide Title 1**

- In a 'Schoolwide Title' program we do not have a list of Title 1 students ... the whole school is Title 1.
- All students can be supported as needed.
- Teachers decide how to use Title 1 assistants when they are assigned to their classroom.
- Mrs. Wright assigns the assistants their daily schedule for student support.

- Testing support ... such as FASTBRIDGE screening
- Safety monitoring at our school ... parking lot, playground, cafeteria, & crosswalk support
- Summer School ... when funds allow




#### **Parent Rights**

  - Have a specified number of college credits
  - Or pass a series of COMPASS tests in writing and math


# School Achievement Data

- Tri City analyzes FastBridge and Smarter-Balanced results and review AYP (adequate yearly progress) and status.
- FastBridge screening tests are administered 3 times a year to all students.
- Smarter-Balanced tests are administered to 3<sup>rd</sup>-5<sup>th</sup> grades in the spring.
- Tri City adjusts instructional practices based on the findings of the assessment data.



# Single Plan for Students Achievement: ELA

- Students receive 90 minutes of English/Language Arts each day. This is taught from the *Journey's* curriculum.
- An additional 30 minutes of reading intervention is provided to some students who are performing below grade-level benchmarks.
- Students receiving interventions will be regularly progress-monitored to determine if the 30 minutes interventions are working.





# Single Plan for Student Achievement: Math

 All students receive approximately 60 minutes of daily, grade-level math instruction from My Math
