We have used multiple methods of communication to reach and engage all student groups within our community. Information shared included specific cleaning and sanitation plans, health and safety information about hand washing/masks/social distancing, and reopening plans/metrics. We specifically prioritized feedback received from our typically underserved and marginalized groups of students, including our Native American students, students of color, and students experiencing homelessness. Additionally, we have prioritized our students living in remote areas who do not have access to high speed internet services, as this group of students would not be able to access any educational services without support. As student needs occur, appropriate staff will be assigned.</p> <p>Students who experience disability will continue to receive specially designed instruction.</p> <p>Students with language services will continue to receive English Language Development.</p> <p>IEP and 504 teams will communicate with parents to revise plans for those students who are identified as vulnerable. Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. For non-removable fabric covered seating, vinyl or plastic seat protectors will be used - Assign seating to maximize physical distancing and minimize physical interaction - <i>Plan to support students with physical distancing requirements, WITHOUT PUNITIVE MEANS. Students are not to be disciplined for failure to comply with social distancing guidelines.</i> <p>Hallways</p> <ul style="list-style-type: none"> - Hallways will be marked with a center divide line and direction markers to keep physically distant. - We will be running staggered schedules to avoid hallway crowding. - Student lockers will be separated 6 feet apart for each cohort member. <p>Classrooms</p> <ul style="list-style-type: none"> - All classrooms; music, PE, core classes, special education classes, will be set up to accommodate physical distancing according to size of room to strive to meet 6 foot distancing guideline.

	<ul style="list-style-type: none"> - Grade level Cohort classrooms will be in close proximity to allow teachers to move to partner classrooms between classes and/or students to cross hall as a cohort using physical distancing. - Mix and match tables and single use desks in classrooms to accommodate more seating. All students will have assigned seats. <p>Cafeteria</p> <ul style="list-style-type: none"> - All eating areas; cafeteria, gym, library, classrooms, will be set up to accommodate a single cohort group following 6 foot distancing guide for both breakfast and lunch with each space being disinfected after each use. <p>Speech</p> <ul style="list-style-type: none"> - Students requiring speech services will move to speech room when hall is clear. Speech services will be a one-on-one service with disinfecting between students. <p>Computer Labs/Media Centers</p> <ul style="list-style-type: none"> - Students will use a one-to-one Chromebook when possible. - Computer labs will be fitted with keyboard covers to aide in sanitizing keyboards. <p>Usable space, <u>based on rectangular or square array:</u> <u>Please see attached school maps with people per square feet listed for each learning space.</u></p>

1d. COHORTING

<input type="checkbox"/> Where feasible, establish stable cohorts: groups should be no larger than can be accommodated by the space available to provide 35 square feet per person, including staff. <ul style="list-style-type: none"> • The smaller the cohort, the less risk of spreading disease. As cohort groups increase in size, the risk of spreading disease increases. <input type="checkbox"/> Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week. Schools should plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure. <input type="checkbox"/> Each school must have a system for daily logs to ensure contract tracing among the cohort (see section 1a of the <i>Ready Schools, Safe Learners</i> guidance). <input type="checkbox"/> Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). Provide access to All Gender/Gender Neutral restrooms. <input type="checkbox"/> Cleaning and disinfecting surfaces (e.g., desks, door handles, etc.) must be maintained between multiple student uses, even in the same cohort. <input type="checkbox"/> Design cohorts such that all students (including those protected under ADA and IDEA) maintain access to general education, grade-level academic content standards, and peers. <input type="checkbox"/> Staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.	<p>Tracking attendance carefully within cohorts will be critical to support contact tracing.</p> <ul style="list-style-type: none"> - Teachers will take accurate attendance through PowerSchool student information system for each class period. - Teachers will also have a daily log if support staff or administrative staff join a class during any given time. - Office staff will keep a daily log of students that enter the back office area or are using any other spaces; counseling office, principal's office, dean's office, isolation room. - Teachers will track any student use of restroom facilities if students need to leave their classroom and use the restroom. <p>Transportation Cohorts</p> <ul style="list-style-type: none"> - This is a stable group of students each day. - Stable groups can be varied by AM/PM routes. - Updated contact-tracing logs are required for each run of a route. <p>6th – 8th Grade Cohorts</p> <ul style="list-style-type: none"> - Recommended: Assign students to grade level cohorts for entire school day. <u>Note: When student needs or administrative logistics require a student to be pulled from a grade band cohort to receive support, it creates a new cohort and additional contact tracing log requirements.</u> - <u>Note: When staff interact with multiple stable cohorts they must wash and sanitize hands between interactions.</u> - Each grade level, 6-8 will be a cohort; and we have designed 4 cohorts within each grade level cohort to provide a stable cohort with minimal contact with an entire grade of students. All student contact will be updated using contact-tracing logs. - We will keep students in smallest cohorts for meals, movement around school according to a specially designed staggered schedule for grade level cohort.

	<ul style="list-style-type: none"> - Students will have restroom access as needed during class time to limit restroom crowding. Restrooms will be marked with 6 foot distancing guides to ensure social distancing. Students may need to wait to enter the restroom if it is at maximum capacity for space. - Staff will sanitize surfaces after each cohort use and after multiple uses in the same cohort. Students will stand behind their seat while desks and other surfaces are cleaned. - Staff will sanitize their hands using hand sanitizer between interactions with different stable cohorts. - Students that are protected under ADA and IDEA will maintain access to general education with their peers in stable cohorts that are designed with inclusion in mind. <p>Middle School Lunch Cohorts:</p> <ul style="list-style-type: none"> - Closed campus lunch to maintain stable cohorts and sanitation. - Each cohort will have assigned lunch spaces that are the same as their assigned breakfast space ensuring to place students 6 feet apart; all students will wash/sanitize hands before & after lunch. - Each cohort will have a separate space for recess after lunch. All students will sanitize hands after playing. - 6th grade will eat in the cafeteria; each of the four 6th grade cohorts in a different quadrant. - 7th grade will eat in separate classrooms in the buildings - 8th grade will eat in the gym; each of the four 8th grade cohorts in a different quadrant. - Supervision staff will sanitize after each use of tables, benches and playground equipment.

1f. ENTRY AND SCREENING

<input type="checkbox"/> Direct students and staff to stay home if they, or anyone in their homes or community living spaces, have COVID-19 symptoms, or if anyone in their home or community living spaces has COVID-19. COVID-19 symptoms are as follows: <ul style="list-style-type: none"> • Primary symptoms of concern: cough, fever (<i>temperature</i> greater than 100.4°F) or chills, shortness of breath, or difficulty breathing. • Note that muscle pain, headache, sore throat, new loss of taste or smell, diarrhea, nausea, vomiting, nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available from CDC. 	<p>Arrival and Entry</p> <ul style="list-style-type: none"> - Each student will be assigned an entrance point; a specific door to the school building. Students will enter the buildings between 7:10 – 7:30. - Staff will be present at each entry point to visually screen students for symptoms. - Students will go to their breakfast eating area after their screening. - Students will wash hands before and after breakfast using hand sanitizer stations before they pick up their food, and before they leave the breakfast area.

<ul style="list-style-type: none"> • In addition to COVID-19 symptoms, students should be excluded from school for signs of other infectious diseases, per existing school policy and protocols.
